Seeks: A high level of current income while preserving capital and maintaining liquidity.

## Investment Process

The Fund invests in short-term, high quality, U.S. dollar-denominated securities that generally mature in 13 months or less, maintaining a dollar-weighted average maturity of 60 days or less and a dollar-weighted average life to maturity of 120 days or less. The Fund seeks to maintain a stable \$1.00 per share price.

The Fund's Manager selects securities based on an analysis of the creditworthiness of the issue. Securities may include U.S. government securities, U.S. and foreign bank and bank holding company obligations, commercial paper and other short-term corporate loans, Eurodollars, CDs, time deposits, variable-rate notes, floaters, and mortgage-related and asset backed securities.

The Fund's Manager may sell a security prior to maturity if it no longer believes that the security will contribute to meeting the investment objective of the Fund.

## Sales Charge

There are no sales charges applied when buying or redeeming shares in NYLI Money Market Fund. However, if you exchange Class A shares or Investor Class shares of NYLI Money Market Fund for Class A shares or Investor Class shares of another NYLI Fund, the applicable sales charge will apply unless you've already paid the sales charge on those shares; or, if you exchange Class B shares of NYLI Money Market Fund for Class B shares of another NYLI Fund and redeem within six years of the original purchase, or if you exchange Class C shares of NYLI Money Market Fund for Class C shares of another NYLI Fund and redeem within one year of the original purchase, the applicable contingent deferred sales charge will be assessed.

## Before You Invest

You could lose money by investing in the Fund. Although the Fund seeks to preserve the value of your investment at \$1.00 per share, it cannot guarantee it will do so.
