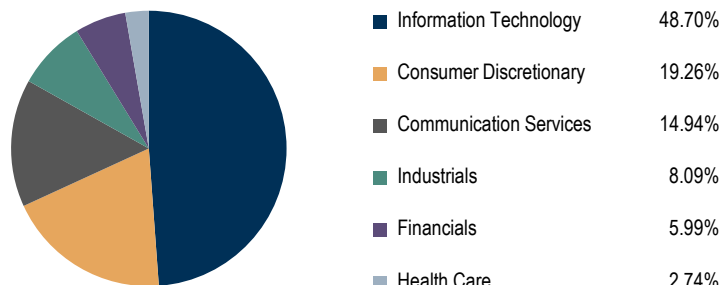

### About Risk:
