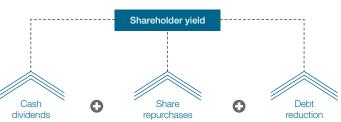

- Remaining free cash flow should be returned to shareholders via shareholder yield

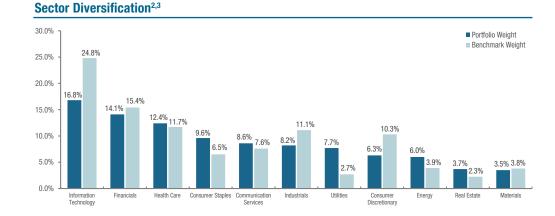
